A genre may be purchased for a guaranteed bid of \$10,000.

There is no charge for this bidding service with the understanding that any failure to execute bids or error in doing so shall not be the responsibility of Arts League of Michigan.

CONDITIONS OF SALE OF ROCK MY SOUL: THE BLACK LEGACY OF ROCK AND ROLL

All property will be offered and sold by Arts League of Michigan (ALM) as agent for the sale on the following terms and conditions:

Arts League of Michigan confirms the authenticity of all artwork from the Rock My Soul: The Black Legacy of Rock and Roll Exhibition.

The minimum bid for each work is \$1,000.00 with incremental increases of \$100.00, not to exceed the maximum bid. A guarantee bid of \$10,000 for any one genre (Hip-Hop, Antebellum, Soul, Juju/Africa, Blues, Funk, etc.) should consider that genre sold and will immediately remove the work(s) in that genre from the sale.

Sale of a genre, supersedes the sale of individual works in the exhibition.

ALM retains all reproduction and publication rights for all (any purchased work from this sale) works in the Rock My Soul: The Black Legacy of Rock and Roll exhibition.

The Arts League of Michigan reserves the right to reject a bid from any bidder. The highest bidder acknowledged by ALM shall be the purchaser. In the event of any dispute between bidders, ALM shall have sole and final discretion either to determine the successful bidder or to re-offer and resell the article in dispute. If any dispute arises after the sale, the sale record of ALM shall be conclusive in all respects.



ARTS LEAGUE OF MICHIGAN ROCK MY SOUL COLLECTION AUCTION BIDDING TERMS AND CONDITIONS OF SALE

At 5:00 p.m. on December 7, 2009, title to the offered work will pass from ALM to the highest bidder acknowledged by ALM subject to all the conditions set forth herein, and such bidder thereupon a) assumes full risk and responsibility therefore, b) has signed a confirmation of purchase thereof, and c) will thereupon pay the full purchase price therefore or such part as we may require. All property must be removed from the premises by the purchaser at his expense no later than December 22 and, if it is not so removed, a handling charge of 1% of the purchase price will be payable by the purchaser per month until

its removal, with a minimum of 5% for any property not so removed within 60 days after the sale. If any applicable conditions herein are not complied with by the purchaser in addition to other remedies available to us by law, including without limitation the right to a) hold the purchaser liable for the total purchase price, we at our option may either cancel the sale, retaining as liquidated damages all payments made by the purchaser or b) resell the property at public auction, and the purchaser shall be liable for any deficiency, costs, including handling charges, the expenses of both sales, or commission on both sales at option, payment will be deemed to have been made in full until we have collected funds represented by checks, or, in the case of bank or cashier's checks, we have confirmed their authenticity. If the successful bidder does not pay for the property, collection procedures shall be the responsibility of the Arts League of Michigan. Unless exempted by law from the payment thereof, the purchaser will be required to pay Michigan state retail sales taxes at a rate of 6%, or any taxes that are applicable at this date.

Removal of Property

Unless different arrangements have been agreed upon, all purchases must be removed by the buyer by 3 p.m. on Tuesday, December 22.

Bid Conditions

Bidders attending the auction are required to sign a bid confirmation card to register for the auction. As a convenience, ALM will, if so instructed, execute written order bids on their behalf, without additional cost. Bidders should use the "Bid Form" and note the terms and designations printed on each. ALM will not be responsible for errors or failure to execute bids.
